### **SUPPLEMENTAL BYLAW #10**

Service to customers within the Town of Drayton Valley Franchise Area:

- 1. The Board of Directors of the Association (the Board) shall be at liberty to designate any annexed area within the Town of Drayton Valley (the "Town") as town service areas.
- 2. Customers of such areas of the Town requesting natural gas service shall be required to enter into the Association's form of customer contract used for that purpose and shall be required to pay a contribution towards the cost of construction of the distribution system required to provide service to such areas in amounts determined by the Board from time to time.
- 3. Customers of the Town, unless specifically excluded from the operation of this by-law by the Board, shall not become members of the Association and shall receive service as non-members.
- 4. The Board shall be at liberty to establish and impose gas rates and service charges for such areas of the Town which, in the opinion of the Board, treat such customers fairly having regard to costs of providing service.
